Item.01/AC 18.03/01: Approval of the minutes of the previous meeting.

Item.02/AC18.03/02:Approval of the new syllabi and curriculum for all UG courses to be implemented from the academic year 2018-19 onwards

Academic Council exercising its powers as per clause (i) Chapter IX section 108 of Act No. 25487/Leg.G2/2013/Law of Kerala Gazette dated 18/12/2014, approved the new syllabi and curriculum for all UG courses suggested by the respective Boards of studies, to be implemented from the academic year 2018-19 onwards

Item.03/AC18.03/03:Approval of the continuation of the title of the programme 'B. Sc. Home Science' as it is.

Academic Council exercising its powers as per clause (i) Chapter IX section 108 of Act No. 25487/Leg.G2/2013/Law of Kerala Gazette dated 18/12/2014, approved the title of the programme 'B. Sc. Home Science' as it is.

Item.04/AC18.03/04: Approval of the change of the B. A. Bharathanatyam programme to Model I

Academic Council exercising its powers as per clause (i) Chapter IX section 108 of Act No. 25487/Leg.G2/2013/Law of Kerala Gazette dated 18/12/2014, approved the decision of Board of studies of Bharathanatyam to change the B. A. Bharathanatyam programme to Model I

Item.05/AC18.03/05: Approval of panel of examiners for the third and fourth semester PG and UG Examinations.

All the Board of Studies of the institution have suggested the panel of examiners for the third and fourth semester PG and UG Examinations.

As per *clause (iii), Chapter IX section 108 of Act No. 25487/Leg.G2/2013/Law*, the academic council approved the same.

Item.06/AC18.03/06: To decide on future course of action regarding the conduct of entry level test for PG admissions from the academic year 2018-19 onwards

As the University has expressed their objection regarding the entry level tests for the PG admissions, the academic council approved that the college can revert to the guidelines followed in the year 2016-17 with regard to the admission for the PG programmes. As per *clause (ii), Chapter IX section 108 of Act No. 25487/Leg.G2/2013/Law* the academic council is requested to approve the same.

Item.07/AC18.03/07 To Ratify of decision taken by the Principal to permit Smt. Sumayya P A to appear for the ESA/ISA examinations with the previous syllabus.

Smt. Sumayya P A has been readmitted to sixth semester BA Economics Programme in the year 2017-18. Subsequently the Principal has granted her permission to appear for the ESA/ISA examinations with the syllabus of 2014-15 admissions. This decision was taken in accordance with the precedence of incidence in the university examination (UO.No.2797/Ac.AIX/3/Physics (UG)2015 dated 20-05-16).

As per *clause (ii), Chapter IX section 108 of Act No. 25487/Leg.G2/2013/Law* the academic council ratified the decision taken by the Principal to permit Smt. Sumayya P A to appear for the ESA/ISA examinations with the syllabus of 2014-15 admissions.

Regarding admission to M. A. Bharathanatyam, University nominee has suggested that admission for M. A. Bharathanatyam can be given to those students who have B. A. Bharathanatyam as their optional. The College admitted students to M. A. Bharathanatyam from all disciplines after conducting an aptitude test, which was not accepted by the M.G University. But the honourable High Court of Kerala waived the order of the University. Hence the academic council decided to give admission to the students from all disciplines for M A Bharathanatyam after conducting an aptitude test.
