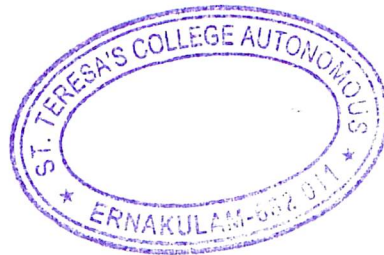

Any candidate may withdraw her candidature by notice in writing, signed by her and mailed to dean@teresas.ac.in , on or before 11 am on 03rd December 2021. Withdrawal once made shall be final.
