The office bearers are to be elected by and from the entire student community of the college.

Representatives (Sl.No.7) are to be elected by and from among the students of each year of the Degree and Post-Graduate Courses.

Only those full-time regular students, whose names are on the Electoral Roll are eligible to take part in the election. Requests, if any, for making any correction, alteration or deletion in the Electoral Roll, shall be submitted to the Returning Officer within the time limit fixed.

Every elector shall be at liberty to nominate a qualified student to fill up a vacancy. The eligibility criteria prescribed by the Honourable Supreme Court of India shall strictly be followed. Nomination forms may be downloaded from the College website. The candidate shall furnish the required declarations on the duly filled Nomination form and obtain the verification report from the concerned Head of the Department. **The Nomination form along with the copies of mark sheets of all previous End Semester examinations shall be submitted to the Deans of Student Affairs on or before 9.30 am on 19th September, 2022.**

Any candidate may withdraw her candidature by notice in writing duly signed by her and submit the same to the Deans on or before **11 am on 20th September, 2022**. Withdrawal once made shall be final.

All the recommendations accepted by the Supreme Court for college elections are applicable to this election. The directives of the Supreme Court shall be supplementary to the clauses contained in the Constitution for College Unions and the rules for the conduct of elections to College Unions contained therein and the same shall supersede any of the clauses that are inconsistent with it.
