## Rules Relating to the Grant of Condonation of Shortage of Attendance

- 1. Condonation is not a right, but a privilege granted on the basis of genuineness of reasons and student's adherence to the basic discipline of the campus and department. Condonation application has to be duly recommended and forwarded by the department concerned. The final authority regarding condonation shall be the Principal.
- 2. Every candidate has to secure a minimum of 73% attendance of the total duration of the semester as provided in the regulation concerned.
- 3. For this purpose, the duration of the semester to which the candidate is admitted initially will be from the date of her actual admission.
- 4. Candidates having shortage of attendance upto 10% can apply for condonation of shortage in the prescribed form on genuine grounds. Condonation will be allowed only twice during the programme of study.
- 5. In case the shortage of attendance is beyond condonable limit such students must repeat the programme for making up the shortage of attendance to become eligible for applying for the examination.
- 6. Applications not conforming to the above Rules will be rejected.
